ARTICLE I

The name of this corporation shall be ELFUN SOCIETY CALIFORNIA NORTH, INC.

ARTICLE II

This corporation is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity, other than the credit union business, for which a corporation may be organized under such law.

ARTICLE III

This corporation is organized and operated exclusively for purposes within the meaning of Section 501(c)(7) of the Internal Revenue Code. The specific purpose of this corporation is to provide social, informational and recreational activities for former members of the General Electric (GE) Elfund Society California North Chapter. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not now permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(7) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

ARTICLE IV

The property of this corporation is irrevocably dedicated to the exempt purposes, and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer, or member of this corporation, or to the benefit of any private person.

ARTICLE V

Upon the winding up or dissolution of this corporation, and after paying or adequately providing for the debts and liabilities of the corporation, the remaining assets shall be distributed to (i) a nonprofit fund, foundation, or corporation which is organized or operated exclusively for exempt purposes reasonably related to the purposes of this corporation and which has established its tax-exempt status under Section 501(c)(7) of the Internal Revenue Code or the corresponding section of any future federal tax code, (ii) and/or to a corporation(s) then existing and qualified under the provisions of Section 501(c)(3) of the Code, as selected by the Board of Directors of the Corporation.

ARTICLE VI

No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office or for or against any cause or measure being submitted to the people for a vote.

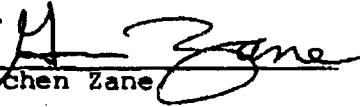
